## **TERMS AND CONDITIONS**

Your Application will be accepted once this application is signed and received by Paul Hopwood Consulting / MINDSHOP together with organising payment of the first Monthly Investment.

#### Investment:

Monthly investment - £200 (plus VAT)

Monthly Investments are payable on the 1st of each calendar month via standing order. Fees unpaid beyond 60 days may result in the engagement being terminated at any time with immediate effect upon written notice.

#### **MINDSHOP Materials:**

MINDSHOP is the owner of all intellectual property in the materials it provides to you. Those materials may only be used for your own purposes and for the purpose of training your staff in the MINDSHOP tools and processes ("permitted use"). You can make and distribute copies of a reasonable portion of the MINDSHOP materials to your staff for the permitted use. You are not allowed to make copies or distribute MINDSHOP materials to any person for any reason other than the permitted use or to make or distribute excessive copies of the MINDSHOP materials for the permitted use. You are not permitted to make excessive amounts of the MINDSHOP materials generally available to all your staff. For the avoidance of doubt, the permitted use does not include any use that is in direct competition with MINDSHOP, such as training non-staff members in the MINDSHOP tools and processes.

### Resignation and Termination of engagement:

You must provide Paul Hopwood Consulting one month's written notice of your intention to end this engagement. The Monthly Investment continues to be payable in full on the 1<sup>st</sup> of each calendar month during this one month notice period. Paul Hopwood Consulting may terminate your engagement at any time with immediate effect upon written notice.
